FLORIDA DEPARTMENT OF EDUCATION CONTRACT NO. 19-181 AMENDMENT NO. 2

This AMENDMENT to the Florida Department of Education Contract Number 19-181 ("Contract") is entered into by and between The Florida Endownment Foundation for Vocational Rehabilitation d/b/a The Able Trust a Nonprofit Organization, (the "Contractor") authorized to do business in the State of Florida, with its principal office at 3220 Thomasville Road, Suite 200, Tallahassee, Florida 32308 and the Florida Department of Education, Division of Vocational Rehabilitation ("Department"), an agency of the State of Florida with its principal offices in Tallahassee, Florida. Defined terms used herein shall have the meanings set forth in the Contract.

WHEREAS, on **June 25, 2019,** the Department entered into the Contract with the Contractor to provide the service; and

WHEREAS, the expiration date of the Contract is June 30, 2022; and

WHEREAS, Section VII. Renewal is hereby amended to read: Subject to the limitations set forth in Sections 287.057(13), and 287.058(1)(g), Florida Statutes, and Attachment C, Section I.F, this Contract is renewable at the option of the Department for a renewal period or periods with commencement and expiration dates as follows:

July 1, 2022 through June 30, 2023 July 1, 2023 through June 30, 2024.

WHEREAS, Section B, II has been amended to read: As specified in Section I.A., the amount of the total payment, or the amount that the total payment shall not exceed is the following: <u>Five hundred forty-nine thousand</u> eight hundred twenty-three dollars and no cents (\$549.823.00) per year.

WHEREAS, the Department desires to amend this Contract to <u>add language to require all participants to</u> <u>be referred to the Division.</u>

NOW, THEREFORE, in consideration of the mutual covenants and conditions hereinafter stated, the Department and the Contractor covenant and agree as follows:

- 1. The recitals are true and correct and are incorporated herein by reference.
- 2. The Contract, Attachment A, I. Project Overview, Section B. Scope of Work is hereby amended to add paragraph 4, with language to read as follows:

4) Participant Referral Requirement

Participants must:

- a. Be known to VR or will have an IPE.
- b. Be between the ages of 14-21
- c. Have documentation that indicates they are a Student with a Disability, as defined in 34 CFR § 361.5(c)(51), which requires the Student:
 - be in a secondary, postsecondary, or other recognized educational program; and
 - be at least 14, but not older than 21 years of age; and
 - is eligible for, and receiving, special education or related services under part B of the Individuals with Disabilities Education Act (IDEA); or
 - is an individual with a disability receiving services from a Florida secondary, postsecondary, or other recognized educational program under a 504 plan or for purposes of Section 504 of the Rehabilitation Act.
 - Other acceptable documentation as approved by DVR.
- d. Have written consent from the parent or guardian before enrolling in these services, if under the age of 18.

The effective date of the Amendment shall be the date that it is signed by both parties.

All provisions in the contract and any attachments thereto in conflict with this amendment shall be and are hereby changed to conform to this amendment.

All provisions not in conflict with this amendment are still in full force and effect and are to be performed at the level specified in the contract.
